Dear New Mission LLC:

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

- Work and travel restrictions imposed during the declared covid pandemic emergency reduced the ability of employees and contractors to complete scheduled work.
- Supply chain issues resulting from the pandemic reduced that availability of construction materials.
- Supply chain issues resulting from the pandemic artificially inflated to costs of construction materials above and beyond budgeted amounts.
- Since the last extension there was a T2 to Bomber pipe replacement, 3760' of 8" pipe installed, 120' of 6" pipe installed, 700' of 2" pipe installed, 31 hydrant/pedestal combos installed, and \$192,141.00 spent on construction.

The new deadline to submit your *Construction Notice* is **January 1, 2028**.

YOUR RIGHT TO APPEAL

You have a right to appeal this Decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt of this Decision. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this Decision:

- File your appeal and a copy of this Decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in chapter 43.21B RCW and chapter 371-08 WAC.
