That portion of the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 4, T. 17 N., R. 19 E.W.M. described as follows: Beginning at the south quarter corner of Section 4; thence N 1°50' W along the centerline of the county road 2614.46 feet; thence N 86°55'43" E 30 feet to the true point of beginning; thence N 86°55'43" E 365.82 feet; thence N 7°47'30" E 12.90 feet; thence N 88°24'45" E 384.30 feet; S 6°27'10" W 913.33 feet; thence N 77°00'50" W 642.15 feet; thence N 1°50' W 726.70 feet to the point of beginning. IRRIGATION METHOD:
Sprinkler irrigation

CONSUMPTIVE USE CALCULATION:
Under RCW 90.03.380 this transfer does not require an Annual Consumptive Quantity calculation (ACQ) because the change is a change in the point of diversion only and will not change the place of use, period of use or the Qi and Qa authorized for use. The crop to be irrigated at the new place of use is hay / pasture.

NARRATIVE DESCRIPTION OF PROJECT:
<p>The water right (<i>Acquavella</i> Court Claim No. 00740) originally authorized surface water diversion from Coleman Creek for the purposes of irrigation of 12.95 acres. The original point of diversion for 0.129 cfs, 51.6 acre-feet per year was from a point on Coleman Creek located within the NW<math>\frac{1}{4}</math>SE<math>\frac{1}{4}</math> of Section 4, T. 17 N., R. 19 E.W.M., Kittitas County, Washington, for the irrigation of 12.95 acres of land located within Section 4, T. 17 N., R. 19 E.W.M. in Kittitas County, Washington. The applicant proposes to change the point of diversion of said water right to a point located 2023 feet north and 1055 feet east from the center of Section 4, being within the NE<math>\frac{1}{4}</math>NW<math>\frac{1}{4}</math>NE<math>\frac{1}{4}</math> of Section 4, T. 17 N., R. 19 E.W.M., Kittitas County, Washington.</p> <p>Attached hereto as Exhibit A is a Kittitas County tax parcel map on which the current and proposed points of diversion are identified. This new diversion point will be a consolidation of diversion points for this right and a companion application (KITT-17-04) and will allow the Applicant to transport the water to the authorized place of use in a buried PVC pipe. The new point of diversion is an existing diversion point that is used by the Applicant's father. The result will be the removal of two (2) withdrawal facilities.</p>
