What is the HEAL Act?

- The Healthy Environment for All Act, or the HEAL Act, passed in 2021.
- It instructs agencies to consider, plan for, and address environmental justice issues in a wide scope of agency activities




Why was the HEAL Act passed?


- The intent of the law is to reduce environmental and health disparities in Washington.
- Historically and today, people <u>disproportionately exposed</u> to environmental harms include communities of color, low income, Tribal lands, indigenous communities.
 - Environmental harms include things like exposure to pollution, any kind of adverse environmental effect, loss of ecosystem functions, climate change
- These exposures lead to higher risk of adverse health outcomes.




Disproportionate Burdens



Ecology must focus our budgetary spending on **creating benefits** for OBC/VP

- Establish a goal of directing 40 percent of grants and expenditures that create environmental benefits to OBCVP
- Create opportunities for OBC/VP to meaningfully participate in our budget decision processes
- Articulate environmental justice financial **goals and performance metrics**





We're explicitly asked to think about things like:

- Community grants to monitor pollution;
- Grants focused on building capacity and providing training for community scientists and other staff;
- Making technical assistance available for communities that may be new to receiving agency grant funding; and
- Education and work readiness youth programs focused to develop career paths and leadership skills for youth
- Creative ways of distributing resources!

Beginning July 1st, 2023, we will conduct environmental justice assessments on:

- 1. New rulemaking
- 2. New grant or loan program
- 3. A new capital project, grant, or loan (at least \$12,000,000)
- 4. Request legislation

*Additional significant agency actions will be identified for 2025





Our environmental justice assessments will include:

- Early notification at the initiation stage
 - OFM, webpage, listserv
- Identifying impacted Tribes & offering consultation
- Identifying overburdened communities and vulnerable populations
- Community engagement
- Identifying environmental benefits & harms
- Identifying options to eliminate, reduce or mitigate harms
- Identifying ways to equitable distribute benefits
- Communicating findings clearly and publicly
 - OFM, webpage, listserv
